Dear Mr. SEMENOV,

On behalf of the Ministry of Transport and Infrastructure of the Republic of Türkiye, I would like to present my compliments to the Ministry of Transport of the Russian Federation.

As is known, we hold Turkish-Russian Joint Committee Meeting on Road Transport via video-conference on 16th May 2022 and Protocol has been signed as a result of the negotiations. I believe that this Protocol will provide great contribution to the development of transportation and trade between our countries.

Under the Protocol dated 16th May 2022, we started to exchange universal (bilateral/3rd country) permits as a new type of permit. Universal permits provide solution to the problem faced by the hauliers of our countries due to the origin of the goods; furthermore, they enable both bilateral and 3rd country transport operations between Türkiye and Russia with a single permit providing great facilitations to the hauliers. In this context, I would like to express that we agree on the issues stated in your reference letter. I also believe that following explanations concerning the use of these permits will be useful. For instance;

- A Russian vehicle can perform bilateral or to/from third country transport operations to Türkiye with this universal permit and with the same permit, they can perform the same transport operations from Türkiye.
- In addition, a Russian vehicle can perform to/from third country transport operations from Türkiye after performing bilateral operations to Türkiye with the same universal permit; or vise versa, it can perform to/from third country transport operations to Türkiye and from Türkiye it can perform bilateral operations to Russia.
